The very first Blessing of the Balers took place right here in Greene County, and I was thrilled to bring it to Harrisburg again this year to raise awareness about our state's top industry and symbolically bless our balers and farmers across the state in hopes of a productive hay season. FIGHTING FOR THE COKEBURG DAM



At my invitation, the House Republican Policy Committee convened a hearing in February to discuss and strategize ways to prevent the potential drainage of our beloved Cokeburg Dam by the Department of Environmental Protection (DEP).

Thank you to Cokeburg Borough Council President Holly Detts-Dranzo and Cokeburg Volunteer Fire Department Chief Dave Lambert for taking the time to testify before lawmakers from various areas of the state. Local



people know their local needs the best, and they did a great job helping my colleagues understand how vital the dam is as both a recreational destination and a public safety training resource.

IMPROVING THE PROPERTY TAX, RENT REBATE PROGRAM

My offices help hundreds of senior citizens each year file for the Property Tax/Rent Rebate Program. While we are always happy to do so, we also see how the application process could easily be streamlined.

I have introduced House Bill 2134, which would streamline the application process by allowing people to simultaneously apply for the rebates when filing annual returns for the state Personal Income Tax. Additionally, my measure would require the Department of Revenue to provide previous rebate recipients with a copy of an application that is pre-filled with information already known to the department.

My proposal is one of three we have proposed to improve the program. House Bill 2125 would establish mandatory processing timelines for property tax and rent rebate applications by requiring the department to decide on a completed application within 10 days of receipt. House Bill 2129 would permanently establish a Dec. 31 deadline to apply for each year's program.

The bills have been referred to the House Finance Committee.
